*Myron McLaughlin, this resolution is telling Mr. Tso to advocate on behalf of Chinle Chapter for these ongoing projects, and to give Mr. Tso a sense of direction to where the chapter needs his voice at the Navajo Nation Capital to push these projects forward.*

**REPORT(a): Eugene Tso, Council Delgate (See written report)**

*Thank you and I will need the resolution so I may push these projects. Del Muerto Headstart is on the priority list but there are three other Headstart facilities here in Chinle and each one needs attention. We had meeting with the Headstart centers and we will continue to meet regarding issues.*

*Meeting with Aging Program will be scheduled*

*May 23, 2019 we had 3 meetings one with NABI, Special Council Meeting, Western Agency and Natural Resources. We also have a meeting scheduled with Regional Division Director in Gallup regarding roads.*

*There also was a conference call scheduled with DES, I was not able to get into the call so they will send me the minutes and I will look into this, the call was last week Thursday or Friday, at the same time we were meeting at Twin Arrows with the Navajo Nation Bar Association. Attorneys/Lawyers discussed certain issues and one was Fundamental Law to include or not include in Title I.*

*I attended the Law and Order Committee Meeting, discussion was on Navajo Nation Gaming. At the time Gaming was approved an agreement was made with the Arizona Gaming Regulatory to have police officers covered 24/7, but at this time there are no funds. There was no MOA, 638 program funds the Police Officers along with Navajo Nation funds and these conflict with gaming regulations. Due to Dr. John Pinto's passing we discussed an appointment of another person to carry on the duties and responsibilities of the Late John Pinto's position.*

*The meeting in Phoenix tomorrow is scheduled at 9:00 AM and Tuesday at 9:00 AM, LOC will speak with Navajo Nation Telecommunication Commission, Christopher Becenti (Director) and other Division Directors. Tuesdays meeting is with RDC.*

*June 20<sup>th</sup> worksession meeting with NABI – on Natural Energy sources*

*We (Navajo Nation Council) have our own priority listing and is similar to the Chapter Priority List.*

**VIII. NEW BUSINESS:**

- a. **CHIN-JUN-19-024: SUPPORTING ARIZONA DEPARTMENT OF TRANSPORTATIONS' BUILD APPLICATION FOR US HIGHWAY 191 ROADWAY SAFETY IMPROVEMENTS.**

*Sponsor, Don Sneed*

*Mr. Sneed explained the previous studies conducted for US Highway 191 (see powerpoint presentation) – 6 studies all together. 2006, 2012, 2017 (448.2-450.5), 2012 Long Range Study, US 191 Roadway Safety Improvements MP 440 to 470. Highway Safety Improvement Program Funded \$2,909,466 for shoulder widening and rumble strip from MP450.5 to MP 453*

*Shoulder widening, rumble strips from MP 453 to MP 464 will need \$11-\$12 Million recommended to the BUILD Application – (Better Utilizing Investments to Leverage Developments) which replaced TIGER, it is open Nationally and you can request up to \$92M. The application needs support, partnership, and crash data to justify the needs. So far we have partnership with 1. NDOT for equipment contribution and support; 2. Many Farms Chapter Delegate, chapter resolution and other documentation; and 3. Chinle Chapter Delegate and Chapter Resolution*

*Lenora Fulton, the Navajo Nation has an election every two years, the Navajo Nation Board of Election gets voted in with two representatives from each agency and we only answer to the Navajo Nation Council and operate by the Title 11 Law and every election year we approve the Election.*

*In 2014: Feb 27, 2014 to May 28, 2014 Candidates completed their Packets to Run for Office, after the deadline we look at their qualifications and they have ten days grievance, we also select the poll workers and train them up to July. The Primary Election at that time was August 26<sup>th</sup>, when qualifications and grievance was open there was none filed and this was for the Navajo Nation President and Council Delegates. Navajo Nation Election Office has an Agency Office and the Navajo Election Board oversees the Program. When a grievance is filed, Navajo Nation President oversees the Executive Branch; Legislative is with the Speaker; Council Delegates are under the Election Office alongside the Election Board; Judicial has the District Courts and Supreme Court with Office of Hearing and Appeal. After the primary election one of the Navajo Nation Presidential Candidates filed a grievance with Office of Hearing and Appeal. As Board of Election we discuss the General Elections which was to be held on November 4<sup>th</sup>. We make sure funds are available to get the ballots printed after August 26 (Primary). When there is a decision made by the courts it is forwarded to the Election Office for us to abide by.*

*September we had ordered the ballots for printing and we were training poll workers, by October there was still no decision made by the Courts so we had to open the election Nationwide and people were coming in for early voting. The courts were still looking into the top two contenders which were Joe Shirley, Jr. and Chris Descheenie as Navajo Nation Presidential Candidates and the grievance was on Chris Descheenie.*

*October 9<sup>th</sup> the Court was held, there was also Court held in Chinle, the Window Rock Courts were still testing Mr. Descheenie on the Navajo language test. By October 23<sup>rd</sup>, 14 days before the General Election a Decision was made and by that time 10,000 had already voted. As Election Board we were ordered by the Supreme Court to terminate the election and get the third runner up on the ballot, to get the ballots reprinted. Printing company would not print the ballots because it was last minute, there was no funding and people had already cast their votes. As Election Board what were we to do? There is no law in the Navajo Nation Government to stop the election so we were meeting with attorneys. In 2000 the Navajo Nation Board of Election postponed an election by resolution and it was four days before the election on October 31, 2014. Supreme Court then took the Election Board to court in Chinle, we were given notice and they told us the Board did not need to be in attendance. When you get served a notice to be in court and you do not attend, you get a warrant issued for your arrest. We cancelled our meeting and came to Chinle, we did not get our say in court but were told that we did not terminate the election, that we did not obey an order and were charged with indirect civil contempt, we were told we were removed and we were no longer the Board. As Board Members we were not allowed any time to speak for ourselves, we did not have our say/day in court.*



*We were only obeying the law and following the law which states that before the election you cannot postpone it for sixty days, but during 2014, fourteen days before the General Election we were ordered to terminate the election. In the USA there is no time in history that an election was terminated by any Tribe anywhere, once an election starts it has to be completed from beginning to end. As Board members we wanted to speak with Chief Justice before the Hearing, and that did not happen, he did not show up. We also wanted to meet with the Navajo Nation Council, and that did not happen either. We were also told that we would be put in jail and I am happy that did not happen. With this action we were prevented from running for any office for eight years, they removed us from our positions using the School Board Policy while the Election Board Policy states that we can only be removed through a re-call. We were removed through an illegal process and we should have answered to the Navajo Nation Council. It has been five years now that we were told that we cannot run for any office for eight years and with all the years I served the Navajo Nation, I have never violated the Navajo Nation Laws.*

*I was Ft. Defiance Agency representative along with Mr. Tom White, Jr. is a Marine who served our country, Norman Begay from Lukachukai, also has no criminal history, Eastern Agency, Michael Cowen also is an outstanding person as well as Fran George. What the Navajo Nation Election Board was charged with is Indirect Civil Contempt which is a criminal offense even though we did not commit any criminal activity. This was a very political situation, we used Title 11, we followed the law but the main issue was that we did not stop the election because you can't while people are voting. Many ballot were received from overseas, what do we do? We have to protect those, and all nine of us decided we would protect the peoples votes and although we were removed the election continued. In November the Navajo Nation Council realized that this should not have happened, we were pardoned by the Navajo Nation Council then two months later in February the Chief Justice decided that that was not acceptable, the pardon was invalidated by the Chief Justice. This resolution is just asking for k'e – to get back to working together, we feel we did not do anything wrong we want your support.*

*Dwayne Billsie, many people feel that the attorneys overstepped their authority. Policies have to be looked at and we cannot allow someone in the Supreme Court to make rules for everything and overstepping the three branch government. We cannot allow this to happen again and Navajo Nation Council laws will have to be amended.*

*JoAnn Dedman, serves as chairperson on Commission of Navajo Government Development, this subject has to be looked into so if you could refer this to the ONGD perhaps we can look into this further, we tried to meet with Election Board Staff but they are not very receptive. Thank you for your efforts Ms. Fulton.*
