So, before it's all gone or something, instead of selling to one

So that's what we're doing right now and also got another Legislation that also I dropped that's going forth too, again is our Dog Control. I took out the preservation and the By-laws Regulation. They are making that one with sharpened teeth for me. So that's going to also come out and we're going to push that one and also request for some funds for more Dog Control Officers. We are making be added to it with our Legal Counsel. So, that one is like that. And then we also have that Community of One is also moving forward. We're getting Chapters across the Navajo Nation the resolution to back us up on it. That too and the cause that one as is right now, right now, the government with the 4 Oversight. They kind of don't give the rights to the voting people. The ones that voted don't have the rights to their Council Delegate to cover their Chapter areas, like big areas like Chinle. Most of the Chinle areas under RDC in Health and Education. So that's not really the right of the people's votes. It is forwarding in that manner over there. So that's going to be a real fight on the floor because some don't, really, some don't, they think it is set because some are Chairperson and Vice Chair and because of that, if you're going to get something to the Resource and Development Committee, you have to look up Ricky Nez or the Health and Education Daniel Tso. So, so only four Council Delegate, besides Speaker of the Navajo Nation has all the authority. And then the law says it is the same. The Council Delegate all help, all the same authority so they can help. So, that really violates the Navajo Nation way of life. So that is way that one is moving forward like that. So, that's going to come up, maybe Spring or Summer Session. I mean, Winter Session. So, hoping that we're going to push that one through. They are working on that one. And then also we're meeting with Dr. Shabala in regards to Natural Resource and some issues that we have and some things that we keep pushing. And also, that we're going to be meeting with State Conservationists regards to the irrigation project across from the canyon all the way to the Old Valley store. They are going to design that for us. I don't know how much that will cost. So, trying to push that one faster because we want to ask for the ARPA Fund on that one, too. And so, regards to that master plan on Virgin Land up on top of Holiday Inn that one also, we're asking for a two-story Office Complex. That will be ours and the Chapter will manage that one, and the Chapter is going to be issuing out business site. It will be filed that way because it's going to be under the chapter. So, the Chapter might start thinking about having another office and having another employee regards to that. It will be set like that. Otherwise, we just have to give it to RBDO. So, keep your heads up and see what you guys can do regards to that one. So that's what will happen there because we get that land back it's going to be under the Chapter. That's how I want it. So today we had a meeting on the Three Turkey Ruin. We are working on that one too. So, we were going to request for some ARPA Funds on that one. there are two roads I'm going to ask Oscar to work with me on that one and also Ervin Shirley from Grazing Committee. First thing we have to do is withdraw that land. We discussed that so that's what we're going to go next on that one. So, and I want the Chapter to have authority on that one. We don't want to give any proportion that to anybody else. I like it the way it is right now. So, I have been following that one and other little things that we're doing here. And we approved FY 22. There were some amendments added; the Condition of Appropriation regards to American Disability Act. It applies to all disability and to accommodate them we are not prepared for them. That was what I requested for them and it was vetoed by President. Just as a while ago, we were talking about drought emergency. The 0017-21 that one to 1,161,000, I don't remember, its over one million that requested for all Chapters for emergency. He also vetoed that from us. So, now we're pushing forward with what we have now and also in regards to the flood area, They responded to us and we will be meeting ACE AmeriCorps of Engineer. So, I took some pictures that got the water that's running off the hospital and also from the south side that was covering the whole area and there was flowing all over. I took some pictures of that, so I'm going to see if I can give that to them to again. And also, on the 13th and they were asking you guys if we can use the Chapter. We are inviting the Resource and Development Committee to have a regular meeting there. That too. Regards to the flood area, irrigation canal we can discuss with them maybe in the morning first before the meeting starts or

b. Chapter President, Dr. Rosanna Jumbo-Fitch

Chapter President Rosanna Jumbo-Fitch: September Report is attached.

President Rosanna Jumbo-Fitch: I have also posted my report onto the screen, so you can also look at it as well so Ya'ha'teeh again those that are attending, my family and my people. September 2021, we have been working on a lot of our projects from Fiscal Year 2021, as well as trying to find funding finalized, the scope of work and also we've been submitting a lot of documentation to the various departments and also working continuously with the ARPA applications and submittals. So overall, I've been working a lot with the resolutions and finalizing them. We've attended a lot of meetings within the past month. We had our meeting later at the end of September as we were closing out our fiscal year. So, we've had a lot of a lot more days to report on. The first item we've completed since the last meeting we've had is we've went and went to meetings with Senator Mark Kelly's team, which was in conjunction with the Senator's office, as well as his constituents, which came from the Valley, Prescot and also the Flagstaff area. They were invited to tour the canyon, as well as meet with the various departments, including the Apache County. They've also met with the NTU. We've also had the Sheriff's department and other various departments. We discussed the hot topics the school district was there. We reviewed funding options that could be possibly reviewed and the Chinle Chapter we presented on our flooding issues in regards to where the Chinle Wash and Nazlini Wash flood our community members that live within the area. One of the areas we did review was also the the bridge locations for what we are proposing for Fiscal Year 2022. So, we provided information in regards to that and also the current flooding events and how our homeowners and community members do get flooded. And we do have difficulties getting emergency response as well as assistance to them. So, we provide a little presentation in regards to the Senator's team. So, they've been coordinating and kind of giving us information as they receive it in regards to possible funding options and resources. We've also been I've also attended a work session a couple of times this past couple of weeks with our Chapter Staff and Officials in regards to Ethics trainings and also reviewing some newly proposed ordinances, whether it's for trash and then also reviewing our Rules of Order for Chinle Chapter Government so that when we have a standard Rules of Order that we were able to review and follow at our meetings. Also attended some leadership meetings with RDC and we've also done trainings with the Chinle ASC Office in regards to the ARPA bathroom additions. We did a lot of reviews on what could be required, what's project ready, what qualifies and also what the cost and also the methods that we need to go about in order to implement these projects. I've also attended the Chinle Service Unit Town Hall Meetings just to get various updates in regards to Health Care and also any areas that may be needing assistance within Community Service Unit and also they've presented on the various departments and what programs they are assisting with. We've also been doing continuous meetings with the Canoe Construction owner's Rep. So that way we are staying on top of the Vendor Village Projects. We've provided various updates in regards to the Department of Economic Development and giving

them information in regards to our project schedule, our project budget and also what items we're still needing to complete within our project task. That specific project, we are working to obtain the clearances for the land, as well as getting legal land surveys and also preparing to ... Architectural Engineering information so we can solicit that project out for bid and then also just continuously working with DED and trying to get funding opportunities for that particular project. We've also had I've also attended the Community Development Block Grant. It's another opportunity to get some sort of funding for the Chinle Chapter Community members that had a few qualifications. So we did review those options of how we could possibly get maybe submit for funding opportunities, but in regards to our access points to the watering wells. So those are some options that we did talk about. And then throughout the month of September, the beginning of the month, I did a lot of review and revisions to our ARPA applications, working with the Chapter Staff, Walton and Tyrone and also to TiShawna in regards to gaining more information for ARPA, the American Rescue Plan Act. We so far to date have gotten information in regards to the bathroom additions, as well as the water lines. Working with the Chapter Staff, we've compiled a lot of applicant information through OEHE as well as....background noise... and also HIS in regards to those community members that have previously applied. They have been on a waiting list for some have been waiting, waiting for years. But we revisit those applicants and we had to provide more details in regards to the ARPA requirements. So, we worked with the CPMD, Community Development in updating those. So, we've had the Chapter Staff go through and verify the exact location of the applicants, their phone numbers, the amount of people living in the homes, what type of dwellings they have. And we had to fill, verify all that information and put it into an Excel document, as well as a mapping system. So that way, other entities were also able to obtain the information needed. We don't have a 100 percent guarantee yet from ARPA, but so far we have been trying to move the projects forward for bathrooms and water lines, and it involves those community members within the Chinle Chapter in the Valley area, Chinle Community and also Del Muerto and also down towards the canyon area. So, we are trying to get those that have been applying some type of service for sanitary, their sanitary needs. We've also had our Chapter Staff attend the Three Turkey Room meeting. That's the Delegate was talking about. But we are having the Nazlini Chapter at this time take the lead on that particular project as it's still a very early design stages. We've also been working with the Community Wellness team. We've had been approached by the various departments within the Chinle Community, whether it's, IHS, Special Diabetes or overall just being able to highlight community wellness with COVID and all of the existing health conditions that a lot of our community members have. We've presented an opportunity to our Delegate in regards to pushing community wellness. We have a lot of resources available in the Chinle area where we have a Wellness Center, but currently is being outsourced for COVID 19 relief. And we also have our community wellness at the chapter, but it's currently closed due to COVID 19 protocols. So, we did propose and gathered information and data from Chinle IHS and also other various departments throughout the Navajo Nation, and to try to propose a possibility of submitting some type of ARPA application for the Chinle Chapter Community. But we are still waiting on that project update. We've also been trying to meet with our local community members and try to gain information in regards to an access road. So, we've met on site behind the Department of Behavioral Health. So, we're working to get some more information in regards to how we can go about that process. We have existing roadways that we're trying to address for community members so that we were able to provide them safe and efficient access from their property line through possible Department of Behavioral Health areas. So, we've been trying to gain some information from BIA, as well as those various departments in order to gather that for those community members. We've worked with CPMD as well for our project, the N7 Solar Street Light. We have signed our documents, we have completed our grant template. We have submitted it to the Navajo Nation. We've received a tracking number, so we are requesting assistance to have that particular project pushed through the 164 Process. We're also working with the Navajo Headstart. We did have a meeting myself and the Chapter Manager in regards to what their needs are, what we have previously agreed to in our agreements and resolutions. So, we had an overall meeting to recapture what the goals are for the Navajo Headstart. So, we are also waiting for a.... inaudible....executed for the Chapter and Headstart. Other projects we're working on is a Local Solid Waste Ordinance in regards to our trash and how we can inform our community members to pick up to clean up and also not to do any more illegal dumping. So, we've been working with

the Prosecutor's Office as well as the Navajo Nation EPA and also their Legal team and trying to develop some type of Local Solid Waste Ordinance. So, we're able to try to provide an enforcement technique to help prevent illegal dumping within our Chinle Chapter Community. And then we again are also continuously meeting with our ASC getting updates in regards to specific items that are Chapter Officials and Chapter Staff need to adhere to as the end of the year was closing out. So, we had a couple of meetings in regards to that. We've also had meetings with our Department of Justice, our Chapter unit, to review our Rules of Order. A lot of any new items that we propose as a Chapter, we have to provide our DOJ to review it, to make sure we're in compliance. So, we've had various meetings with him as well. Our last work session, we reviewed our Chapter budget. Our Chapter Manager broke down each of the vodes, as well as the process in regards to how we review our monthly compliance forms. We did a overall project review of what we've completed to date, what process we're in and what we need to look at moving forward. So, we created the FY 2022 lists. And again constantly reviewing the Ordinances, Rules of Order and also any other community concerns at that time. We've also attended the Board of Election Supervisor meeting last week. It was kind of a vagie invite that we've received. We did receive a memo in regards to our Local Sales Tax pro Sales Tax Project and we were invited to return. but we did not. We did not go anywhere with our project. So right now we're trying to get some more information in regards to what specifically they need from the Elections Office so that again is on standby. We've also been trying to keep up with our Phase-In. As I mentioned in our announcement, our Chapter is going to be going back to in-person meetings starting Monday for our October Planning and Regular Meeting, and we will follow COVID 19 protocols that are in place as of to date. And overall, moving forward, we've been contacted by Representative Tom Q Halloran's team to try to provide some Veteran Outreach. So, we had a brief meeting this morning in regards to what Chinle Chapter can provide. So, we provide open doors for the Representative Tom O'Halloran's team to come out to the Chinle Chapter Community and try to provide some information for our current and new Veterans that may be in need of some kind of assistance information or overall just being able to provide them some type of support system. So that's the event that we are planning, so we'll have further meetings to discuss that. So overall, we're trying to provide opportunities for our Veterans as well and trying to get information from our new Commander. Overall, this past month, we've been meeting and returning information to our community members, trying to get them their assistant concerns answered and overall just working closely with our Staff and trying to get these projects moving forward. We've also received one Community Land Use Planning Committee member application, but we have reopened it to October 1st as we are trying to get more members for our CLUPC. The CLUPC helps to overall plan for our community development. It helps for us to have a third party committee to help plan for future development, also current projects, whether it's working with community members or current project lists. So, we're again resoliciting. We have a due date on October 1st and then we'll do interviews following that. But overall, we're trying to mainly move forward a lot of our projects. And the big topic right now is the ARPA, as it is a lot of money, a lot of funding that is available for Chinle, our Navajo Nation Chapters. We did submit for 260 applicants within the Chinle Chapter Service area, so we're hoping that we get all 260 that we can at least provide some kind of water and also bathroom addition, additional assistance too. So overall, that concludes my report. And does anybody have any questions?

c. Chapter Vice President, Shawna Claw

VP Shawna Claw: Good everyone, my family, and people and then I'm going to go ahead and just give a brief report. Our Official has already given an informative report. It really is that way. Right now, it is the beginning of winterend we appreciate that, and the, the manager also. You have done a good job. I will do a brief report. These Resolutions hat have already been turned in and approved. We are also appreciative of those. We are approaching a new Fiscal Yer. The Secretary/Treasurer reported well. The Chapter Priority Projects are like that I think we still need some work done on it and we appreciate all those that are involved. Starting with our Delegate, Mr. Tso, LDA Dedman and then our chapter Officials, Elected Officials in Administration. Also, I just want to thank our AmeriCorps and then also our PEP workers. I was able to assist them on Friday, this past Friday with their distribution. We were out there for two hours, and we got an opportunity to distribute some of the donations, such as hand sanitizers and then also the children and adult mask, as well as dog food. So, thank you for the team that went out to collect those donations. And I believe they do have upcoming dates where they will be doing more distribution and then on behalf of the chapter. There was discussion on a celebration of N27, a collaboration with Nazlini Chapter, as well as Chinle Chapter. This afternoon we did receive information that was shared from Nazlini Chapter. I believe there are some dates that were recommended and we as Chinle Chapter, we will be notifying the public of the date of which will be selected. So, during that time, we are encouraging our community members, our voters, our community organizations and our past leadership to be a part of that celebration. GO Oscar Bia Sr.: Yes, Ya'ha'teeh those online. Is it audible?

GO Oscar Bia Sr.: Ok, good, you guys hear well. The first report is Windmill repair. Two have restarted in Chinle Chapter boundary. It is good, it has been running two or three days. They are halfway full. Please take care of them when you pass them by, water, windmill, take care of it. Do not abuse them. Inform each other of them when at meetings, church wherever you go tell each other of them. It is good. For your livestock even though it is raining and water pooled some places. Then, the branding is almost done but there is only one left and that is way it is not done. It will be done some other time.

Ms. BettyRose Draper: Background noises...

GO Oscar Bia Sr.: It's somebody talking. And then, there will be work being done in other places. Then, I have been attending meetings. Meeting over in Many Farms, and we have our Officials meetings through phone conferences. Meetings like the Grazing Official meeting, those are done, Chinle Agency are done. Then after this month there are others. Then there are several resident reports. On that one, they are saying the horses are going to be removed. I did not set a date so when the papers are completed. And then, take care of your livestock that are wandering around. There are reports of livestock being stolen, beef. Instruct each other to care for livestock even if you don't have

livestock. Long ago grandmother would say that She went visiting homesteads but today it seems we just steal from each other. The person who steals is not afraid. For us that have livestock we are afraid. Look after each other. If there is a person herding a livestock that does not belong to them, that you question. Whose livestock is it? Is it your

is a person herding a livestock that does not belong to them, that you question. Whose livestock is it? Is it your own? Ask. Us Grazing Official might have to look and we will find them is how we are seen. That is not our responsibility. Maybe if we were paid or if you put in gas for us. Look after each other and also land disagreements too. First, go to places for it that why people are not confronting. Whose livestock is it, whose house is it, whose land is it? Ask those questions before you go out for it. We were just voted in. Have meetings among each other. That way it is good. That way when I'm out branding or fencing, or clear a Homesite lease, I will not have to be dealing with people saying how it is over here, telling the Chapter Officials or Administration Staff. I also tell them where I am going and that is where I am going. Sometimes, I am in the office. There are documents that need to mail out to grazing permittes, and land use permits, and answer questions for those that have questions. It is also not easy when a homeowner has moved and you're over here trying to navigate for them. I have a lot of those that I will be working on. Then there is the NTUA right-of-way, powerline right-of-way, those are theirs, they already done land preparations for it and will be fencing. They will be fenced off. Make a way out for them. A wire may fall during a wind or when a fuse break and the electric goes out. So, they have to go out there and follow the line on land or waterlines, do not fence them off. Inform them first that you are going to be do a land withdrawal or for grazing. Let them know. That would be good. That is what happened south of Holiday Inn. The water is not good, it tastes of metal and dirt, and the waterlines have rusted, those are where the roads go so they can clean by applying water supplies. That is how the waterlines are among us in

Chinle. Then there are those of us that don't use a lot of water

even though we have waterlines. Tell each other if you're going to be fencing up where NTUA travels. Tell each other, it will be good. If I get reports and I tell them they will say the road is or responsibility so that is why ask why it is being fenced up. Do they know? They are NTUA roads, and they have been traveling them long before. You can also say no that can be requested. We obtain water and electric from them. I was raised on oil lamps, and I would do my homework. With no waste waterlines. No shower for two to three months is how I did my schooling. Today, we have everything, and we are stingy to each other with the waterlines and electric roadways. People start going to Department of Ag and report these even in Window Rock, or they call the Chapter Officials. Why not tell me, I do not have horns. I do not lecture. I only advised how to, and that is what I will tell you. You complicate things that are being done over there, like funding or jobs that need to be completed. He is not a Grazing Official, even though he does have some responsibilities pushing documents forward. You have to come here first. Then we can discuss land and grazing. The way I think about it is that; do things right and have an understanding, that way it is good for you. You don't want anything bad, only good, if we work together, teamwork. Grandfather used to say "teamwork, a reign equally moving". That is why correctly live together, work together that way we do not complicate things. If we argue then you might lose. No, not like that. We are responsible for those. Electric first, fix that first, if you do not know how then you can come ask how to do things. Work with K'e, that is all there is today. We don't even shake hands anymore or we glare at each other. Do not speak like that. Take care of your livestock and your land. Wherever you travel. Do not throw trash off anywhere. Talk to your grandchild that it is Mother Earth. You live on it. Live on it right. I receive calls anytime of the day. I am now receiving calls about disturbances, bootlegging and family complaints. All of that is the police responsibility. I do not deal with those. Speak to them diligently. Just like when I go to the store or Post Office people ask for money. I ask if they want a pop or a sandwich and they no I want money. Talk those and take care them. All of you listening I am not saying these things to criticize you. I am reminding. Just to let you know. Take care of your fences, close your gates. If I did it for you, your not going to like it and your going to throw off the gate. I do not go to place that say No Visitors, because it says No Visitors. Take of your selves with those and tell each other. Then there are a lot of cows limping with wounds and dislocated joints and some horses have long hooves. Then the wood haulers, do not throw away your trash there. Those of you buying wood let them know. Don't dump your trash just anywhere, please. Tell each other my family, people all of you. That will be my report. Someone can teach us. The SWCD also

irrigations and how to repair them and who will get services first, how can we get funding for it. We have meetings for those too. I also represent for that too. Some Ranchers know me and I talk with them about livestock and land I learn about that too. Thank you. That will be all.

President Rosanna Jumbo-Fitch: Thank you my grandfather Oscar. Do anybody have any questions?

He is in charge of the water and forest to, I said. So, maybe tomorrow he can let me know and I can drop a Legislation to get Grazing Committee out of the, as a program. You guys are not a program. That is why I am going to get you guys out of there and back on top of the Division of Natural Resources with the Resource and Development Committee. If they're going to be still there after my legislation by a Committee of one. That will be like that. Just to let you know. And then Committee also approved funding for hay and grain. Some got delivered. So, I don't know if you know if not let us know. Thank you.

And there's another young lady that is on there. Her name is Tara Tara. She is assisting with this. Also, that is still available if you guys have any community members out there that is under quarantine or it came a positive. We do have Bashas gift cards that we do and that's provided by Nava and Hopi. We do purchase the food. They'll give us a list. We deliver and also in PPE gear. So that is available here at the Chapter too. So, if you guys have any community members out there doing or on quarantine. Next one is, I will do a fiscal report end of the year. I was going to do it today, but right now I'm not really good at state of mind. I'll present it there in the Planning Meeting. I will present everything because the report will not be actually accurate until I actually close down with the last sales on the tomorrow and Thursday. After we get all that done. I'll have the correct numbers, the correct amount on FUND one due to the resolution that was passed at that state that all the other funds are closed. Just the final one is going to go up due to the revenue for the next two days. There Chinle Chapter has been helping and assisting Oscar also. We've been branding a lot of cattle with him. There was summer youth that was selected he kept and he took them on weekends or during after hours or after school, he'd done a lot of branding. I also assisted sometimes helped him out. There's a lot of families out there that really do appreciate it. It does feed us or does give us a good meal to eat. There was one family that really gave us a really good meal. And you know, there's a lot of people that does appreciate things out there. So, there's some time there's ups and downs where we do, but we've done a bunch of branding throughout the last three months. We do work really closely with the Grazing Rep. also and also with the inventory and stuff. Yes, our Vice President did walk through it and we we haven't make another date yet, but hopefully we'll get a date soon. I've been very kind of busy trying to close out and do the end of the year stuff and on conference calls constantly have like three things ah, four conference calls at one time. It's crazy. But we we manage. We get it done. We do everything as possible for everybody that can assist. Previous. Our Chapter President already done a big report. What we've been working on, what we've been pursuing. But the Chapter Admin is trying to do their best to help everybody. The only thing that I request from the Officials is we need to go relook over the Plan of Operation. The Plan of Operation that is set right now. There has some issues with it. For some community members coming up to me and asking why I changed it or why I'm the one that pursued on a different level. I believe that mostly one of the home discretionary, I know there's a lot law passed from the RDC that states that any Navajo Nation funds they have to have a Homesite lease. There's a lot of them that we deny for no Homesite lease a lot of them say that it used to be a long time ago house, but I do tell them that you can probate or go by the Land Department and reissue that homesite lease under your name. But some, some community member does not really understand that. So, I don't know how better to explain that to our community members. Thank you for passing the resolutions for the for all the fiscal year budgets so we can move forward and reopen. I know our Chapter President did stated that we're doing a soft opening, but starting tomorrow Chinle Chapter, already have everything set up. So, the lobby will be reopened. We already have all set up. We already have our plexiglass up. We already put the ramps back on. We put the steps back on. We are sanitize the building. We put up posters. We put up everything, cautious signs and everything up. So, we're already going to be reopening by tomorrow the lobby. So, the window service is not going to be right there, no more. So, you can come into the lobby up to three people. Not a whole big crowd inside or anything like that. So, we were saying up to three people because it's a small lobby. So, we have that done. I know it's supposed to be done by Friday, but we hurry up and jumped on it and got it out the way. We do have PPE that are available. We're going to start trying to put some stuff together and start passing out. I know one certain shipment is for the schools, so we had to divide that up and then start giving in local schools. We said Chinle Unified School Districts, so we're going to be dividing it between some schools and try to get them some face masks, some hand sanitizers, some wipes and stuff in that nature. And then we're going to try to hit some Senior Centers. We we did deliver a lot to Senior Centers, but I believe they were going to give them some more just to keep the elders safe and give them some more extra PPE. Also, we do got a big shipment from

Phoenix, so we're trying to think that we'll do that on this coming Friday. It just depends on our schedule we're trying to work with our schedule was just to do our closing our books and trying to get things set up. So, we're trying to set everything up as soon as possible, then we'll try to announce it in. We do have a lot of hand sanitizers. We want to give some to the local businesses and let them set it up outside or whatever when they come in. Or, you know, community members can go ahead and grab some little hand sanitizer bottles that we're on. We did pick up, so we're trying to put that together also. Were, we'll probably be advertising for the new AmeriCorps program the fifth year. I believe Tyrone Begay is actually watching that over for us. I believe we got the notice. So, we'll probably be advertising for the AmeriCorps members again. So, you know, if you have community members out there, have their kids or anything that wants to do this program, you know they can more welcome to call Tyrone Begay, our Chapter Planner, and he can walk and answer any questions with the program with with the AmeriCorps. Also, we have some programs that we want to set up with the Head Start and also with the Senior Center. I believe the Chapter President they brought up that they want to do MOU MOA with us just to state some agreements where they're inside of our complex. We haven't renew our agreement. So that agreement that we have to re relook over. So, we'll probably bring that during our Planning Meeting. But anything else, I believe I can go through the whole Financial Statement when we close out end of the year, and I'll bring that down during the Planning Meeting. I'll have printouts and anything that was needed. I did change a little bit on the budget. If you see the email, you guys at the last minute I forgot about the Navajo Nation President signed a three percent wage increase CWA, so I had to amend the number (23) twenty-three to make sure that three percent (3%) was in there for the main, the main staff, the permanent staff, so that he did signed up on the 27th. So, it did sign that \$2 million for Special Revenue Fund for our project. So, I don't know when they're going to put that in WIND. I don't know how much Chinle Chapter is going to get. I know that our Honorable Delegate brought up the money that was out for hay, grain and stuff. I believe that was a \$4 million and they're going to go with a 50/50 formula. I suggest that maybe we sit down with the Grazing Rep. and get all on the same page of how we're going to utilize this funding. So as the Admin. side, I can know how to budget and how to hurry up and get ahead of the game because you know how I am, I like to get ahead of this stuff and be prepared and be ready for it right after it comes out. I can hurry up and budget and get it going and see if these are approved or allowable or disallowable. So, I suggest that we can meet on that and see how much funds are going to be available and what we should be buying and what we could provide on that. I know there was a suggestion of only for permit holders, but I know there's another Council Delegate that was saying that if they own livestock. So even that we need to sit down and see what we can put together on that, as you three Chapter Officials Admin, and work with the Grazing Rep. That's about it. I don't know if I forgot anything. I was at the site, but I'm back over here, so I don't have everything on me, so I don't know if you guys have any questions for me.

President Rosanna Jumbo-Fitch: Thank you, Walton for your report. Any questions or comments for Walton, our Chapter Manager.

Delegate Eugen Tso; Madame Chair, my daughter.

President Rosanna Jumbo-Fitch: yes, go ahead.

Delegate Eugen Tso: Walton, I forgot. We are in the process of, already the Chinle Agency and Western Agency approved registration to rescind the homesite lease. We are working on that one. That one is on the way too. So, we're going to change that one because it doesn't, it doesn't allow, it isn't done in Dine Way. Just like Grazing Committee said, It isn't done the Dine way. It dismisses everything, the law. That is why we said it isn't done right. Herb Yazzie, the former Attorney General, I meet up with and we are meeting. In that regard. Also, we're pushing the legislation. Me and Vince James regarding power line and water line to waive homesite, consent waived. So, we have been meeting with NTUA on that because we're going to be dealing with a lot of waterlines, and a lot of powerlines. That is why we're just going to waive that section turned off for consent. Thank you.

g. Heather Wilcox – Yeego Project

Ms. Heather Wilcox: All right. Thank you very much, Rosanna. Would it be possible to share my screen or get host permissions to do that?

President Rosanna Jumbo-Fitch: You are presenter at this time, so go ahead.

Ms. Heather Wilcox: Thank you. Give me one moment. All right. So, my name is Heather Wilcox, and I am reporting back on the Qualitative Process Evaluation of Yeego! Healthy Eating and Gardening at Two Navajo Elementary Schools. I completed this project as a thesis for my Master of Public Health Program at the University at the University of Washington in Seattle. This project is part of a larger study of the Yeego Healthy Eating and Gardening Program, so I'll begin with a quick overview of that program itself. The Yeego Healthy Eating and Gardening program, which I'll be referring to, is just the Yeego program is a school based health intervention that aims to increase fruit and vegetable consumption among Navajo Elementary School children. The intervention is a combination of a school garden and a culturally relevant curriculum on gardening and healthy eating, and it's designed for third and fourth grade students. It was developed by a research team from Dine College, New Mexico State University and Fred Hutchinson Cancer Research Center in Seattle, who worked in close collaboration with community leaders on the Navajo Nation to design curriculum content. The Yeego Program is currently being evaluated in two communities being Shiprock, New and Tsaile, Arizona. And there are three participating elementary schools in each of these communities. The schools were randomly assigned to study conditions such that one school in each community received the Yeego program during the first year of the study, while two schools in each community served as controls and received the program in the second year of the study. My thesis was specifically concerned with the two elementary schools that received the program in the first year and after the program was implemented and these two schools, I conducted a process evaluation of the intervention there. So, while these outcomes evaluation looks at whether a program worked or not, a process evaluation looks at how a program was implemented to produce the outcomes, and one component evaluation is measuring implementation fidelity, or the degree to which the intervention was delivered as it was actually planned. Collecting data on this is important because it can strengthen conclusions that implementing the intervention is what actually produced the observed outcomes. And that said, not many studies have conducted process evaluations of school based programs to promote fruit and vegetable consumption, and to date, none have been conducted on the Navajo Nation. So, the goal of my study was to describe implementation fidelity of the Yeego program across the different contexts and to identify areas of delivery that could be improved in future evaluation or dissemination of the program. Prior to my data collection, the Yeego program was delivered by a total of five intervention staff across the two school sites. The intervention staff had expertise in agriculture, nutrition and or gardening education, and they delivered the Yeego program lessons every two weeks to each classroom, alternating gardening and healthy eating lessons to collect data on intervention delivery. I conducted individual interviews with intervention staff and with teachers whose classrooms received the intervention, and I developed interview guides that asked open ended questions such as how they prepared for the lessons, how students engage with the activities and their suggestions for improving the curriculum. I also reviewed fidelity checklists that intervention staff completed after each lesson they delivered. In each checklist, they reported information such as whether the lessons started and ended on time, whether they had the necessary supplies and which lesson components they covered. So, and then I performed qualitative analysis on all of that combined data from the interview notes and fidelity checklists to identify prominent themes and quotations that illustrated each theme across the two sites. I interviewed all five of the intervention staff and eight of the classroom teachers, with six of the teachers at one site and two of the teachers at the other. In total, I identified 14 themes, which I organized into three broad categories that were evidence of fidelity practices, supporting delivery and lessons learned about delivery. And while I won't name everything I identified, I will provide one example from each of these categories and then summarize my overall conclusions. One of the themes I identified in the category of evidence of Fidelity was that all intervention staff use the lesson plan to structure delivery, but variations were common key elements of the lessons were generally present across the sites, but they were not always implemented consistently in every classroom. Usually this was a result of time constraints or staff having different teaching styles and methods to engage the students. A

quote from one of the intervention staff that illustrated this theme was, we had to adapt the curriculum a little bit to the kids. I would look at the curriculum and go, OK, I want this one to be like more of a Q&A interactive discussion so the kids are more engaged. One of the themes in practice is supporting delivery was to actively encourage students to connect each lesson to their families and communities. Students liked when they could connect lessons to their personal lives and experiences, and there were two key ways the curriculum facilitated this. Which were that it incorporated culturally familiar elements that the students associated with family and community members and it used activities which students were excited to bring home, or that they were able to easily replicate at home with family. A quote from one of the teachers illustrating this theme was, I think one of the coolest things was when the kids, like started being able to ask the questions that were actually important to them and like, Oh, my gosh, like, I bought that at the flea market or whatever, or my grandma makes those pancakes just kind of like making connections that feel real to them. And finally, one of the themes identified as a lesson learned about delivery was that improvements could make lessons more inclusive of diverse student needs and life experiences. Our findings indicated that certain aspects of the healthy eating lessons in particular needed to be more responsive to different family and household structures, as well as the realities of food insecurity and being low income. Students at one of the sites also had diverse learning needs that were not always met. Many of them were English language learners and or low literacy learners, and some were in various stages of fine motor skills development that impacted their ability to participate in some of the activities. A quote from one of the teachers illustrates this theme. They said one major blind spot that I perceived and I know that other teachers did too, was the reality that a lot of kids have food insecurity for kids who are poor calories or calories from the findings. I was able to conclude that the program was delivered with a moderately high degree of fidelity across contexts and that there were several areas to consider for improvement. First, modifications should be made to the content and delivery methods to meet students learning needs and enhance engagement. This includes strengthening lesson elements that are visual, experiential and related to Navajo culture. Additionally, the findings suggest narrowing the scope of the curriculum and increasing the intensity of the intervention, especially in regards to the hands on gardening and the hands on healthy eating activities. And finally, while teachers and students were highly receptive to the Yeego program. Teachers were hesitant about being able to deliver it independently. This being a long term goal for the program. Our findings suggest that an area where the Chapter could really assist would be in fostering relationships and inviting community members, businesses and organizations to be involved in the program. Any time or resources that these types of entities would be willing to donate can offset costs that are associated with program materials and teachers expressed needing help with classroom management in order to deliver the lessons, which presents opportunity for parents, grandparents and other community members to be involved. And finally, teachers would value the addition of community members diverse skills, knowledge and experiences related to growing and eating traditional foods. I think So, in conclusion, this study contributes new knowledge to an evidence base for school based interventions to promote fruit and vegetable consumption among Navajo youth. And it also recommends ways to make the Yeego program more acceptable and effective in future studies, and it informs future research to improve healthy eating among Navajo youth. And at this point, I am happy to take any questions that anyone might have. Thank you.

President Rosanna Jumbo-Fitch: Awesome. Well, thank you, Heather, for your presentation and your study, I think you did a great job in summarizing that the project study that you are working on has provided some information to not only the teachers, but also the ability to provide some further information to help assist the community members to develop some more diverse skills and how we can better teach our students to eat healthy. So overall, I appreciate the information you provided in the study you've completed and the resources you're able to help elaborate on for our community member. Ms. Roselyn Yazzie: I have another question. I want to know how long, how long your study or, oh, you're doing the survey, whatever data you collected, how long did it take you and which sites did you go visit? Which schools do you work with and how many parents do you work with?

Ms. Heather Wilcox: Yeah, thank you for that question. So, my my part of the study was just kind of a small part of a much larger randomized trial. The two schools that were involved were. Uh, I've been I've been decoding the names for so long that I'm trying to recall now, Nizhoni Elementary is one of them and the other is Chinle Unified School District. I'm really sorry, I'm having trouble recalling the the name of the actual school, but I can I can follow up with that in the chat box, too in just a moment. So those were the only the only two schools that I worked with for my specific part of the study. In total, there were six schools participating in the larger trial of the intervention. And could you repeat the the other part of your question?

Ms. Roselyn Yazzie: I want to know how many parents are involved.

Ms. Heather Wilcox: So, the parents were not involved in the interviews that I conducted, I only did interviews with classroom teachers and the intervention staff who were helping to deliver the curriculum in the schools because my my piece of the project was specifically focusing on how how the program was implemented. Like how closely it was implemented according to how we planned for it to be implemented. So, the teachers in the intervention staff were really the key people that I spoke to about how it was carried out inside the schools. But the parents were involved in the larger study in terms of consenting for their kids to participate. There was a pilot study before this intervention took place in which community members, including parents, gave a lot of input about what they wanted children to be learning about healthy eating and gardening. I don't I don't have numbers about how many participated in that pilot study, but I can also send a couple of links in the chat to papers that were published about that earlier work to if you'd

Ms. Roselyn Yazzie: Okay, and how long did the survey take place?

Ms. Heather Wilcox: I started mt interviews in June, late June of 2020 and ended in September 2020. So, about four months it took.

Ms. Roselyn Yazzie: Okay. And so, from here on. What else are you going to help out with? Now you have the study done, you have been some statistics. What are you going to do now?

Ms. Heather Wilcox: So now. Um, this study, this study I had personally been working on as a thesis for my my graduate program, but the results of the study are basically being fed back into the larger, the larger trial that's taking place so that the people who are looking at the statistics from like the various evaluations they did at different points in time throughout the trial, they'll be using the results of my study to look at whether the implementation process and any differences in the implementation process at the sites made any difference in outcomes that they observed. And it also just helps contribute to an evidence base for like how, how to implement and the results of of when we implement school gardening programs and in this particular way on the Navajo Nation because we didn't previously have any work that was published about that. So, it sort of creates some initial evidence for the implementation process of school gardening programs on the Navajo Nation, but it also more directly creates context and adds information to the the larger outcomes of the randomized trial, which are are still being evaluated right now, and they're they're still looking at those.

Ms. Roselyn Yazzie: Okay. Whatever you've done and the results are pretty good. Are you proposing an idea with the schools to implement it in their curriculum?

Ms. Heather Wilcox: Yeah. So, the the project team, one of one of the long term goals of starting this program in the classrooms, was to to kind of initiate having it be part of the curriculum. But one of the things that this study highlighted for us is that there really needs to be some more refinement, some some narrowing of the scope of the curriculum and better integration of the curriculum into the teacher's already existing curriculums for it to be feasible for them to deliver on a long term basis. So, yeah, so the answer to your question is a little more complicated than than yes or no, because that was what what the team was hoping for initially was that after implementing it this first time, teachers would be able to carry on with the program if if they wanted to keep doing it with their students. But we've we've learned from this piece of the study that I worked on that that it's not quite in a place where where teachers feel confident in being able to deliver it independently. So that'll be the the topic of future research for it is really refining it and better integrating it with the teachers current curriculum so that instead of it being sort of an an added curriculum to what they're already teaching, it can be something that's more integrated with their existing curriculums and using healthy eating and gardening activities as integrated components of that. Does that answer your question?

Ms. Roselyn Yazzie: Oh, yes, yes, you did.

Ms. Heather Wilcox: Ok.

Ms. Roselyn Yazzie: I think you did a good job. Oh, and I think this should continue. And I've known studies surveys were done, and somewhere along the way it disappeared. And I hope this is a hope yourself and the other teachers, the other schools show a strong interest in developing this into part of the school curriculum because this is a new concept and I think students, always Navajos do it always have done so well when it's on hand, but they're doing it by hand and seeing it and handling it. And I think that would be a real encouragement to to the students and the parents. So, I would encourage you to continue along with the other teachers. I think it's a good idea. It's fairly new. I haven't heard. So thank you for doing it.

Ms. Heather Wilcox: Yeah, your welcome, thank you.

President Rosanna Jumbo-Fitch: Thank you. Any other questions or comments? honorable Tso, you had a question? Delegate Eugene Tso: I did but

President Rosanna Jumbo-Fitch: Ok, go ahead.

Delegate Eugen Tso: I was just trying to think about the study, and I was just recalling when I used to work down at Las Cruces, New Mexico, and our bio Bio Lab by I forgot about it. I had it right here in my mouth. Anyway, anyway, I used to put the all kind of animal birds all the way to the big ones, horses, and for studies of what do we inject into them. All these different kinds of vaccines or things that their horses are using, like they're or animals are using and then breed them almost every summer. And sometimes it has to be every 30 minutes or every hour or every two hours or throughout the night or two days, two to three days, four days straight. Sometimes it all depends on the people that that was there after a study that brings things that for their or for their study. And we would sometimes don't sleep at night. And our Bio Lab there used to have a team to do all this kind of job. But. I was thinking about how the kids were being used to being studied here and there or regards to that. What you guys did. But my main concern sometimes I always figure somebody would do a study on the younger generation regards to parenting and put that into the curriculum. But my guess is way off. But that's always think that because that's where the problem is across the Navajo Nation and also the states and the United States and the world. Look at what happened that January 6th, looking at them just like the little kids doing what they were doing. You know, they don't grow up. So those are the things I was always to get by because that's where the money is going, because that's where all the police are. We had to race with them, put more police out there, put more jail out there, put more wire out there, et cetera. And if all the other criminals are also populating, too, but we never, never, ever think about parenting. If we were to parent our kids starting with me, I'm not a good parent. So, starting with that it would really change the world. I always feel that way. And there's no way you can slash it, so it won't work because so much is the younger generation or parent that we usually last really met to them was to Navajo. It was just emotional and the spiritual and the physical growth all in harmony. It has to grow in

harmony. That's how they're supposed to be raised. And it's always taught on natural resource there and all the wildlife out there. That's how they were taught with all of those, how they can become a person, you know, like if a if a woman or a man gets mad at 20 or 30 or 40 years old, he acts like a little child. That means he never did, or she never did, grew up. So that's how I always feel. So, I don't know anybody ever studied those kind of stuff, but I do feel that some things are needed to around on the reservation to have a study going on. I know John Hopkins does a lot of study as well because I was interviewed one time because of my age and how I feel about jobs. So those are some of the issues we have on the reservation, but we don't we don't see it that way these days. We just we just think it's normal, but we are. Everything is normal, but it's not normal. So, it is how I see it. Thank you.

President Rosanna Jumbo-Fitch: Well, Thank you. Yeah. Any other questions and comments for Ms. Heather Wilcox? If none, thank you, Heather, for being patient and being able to come back and present your your study to our Chinle Chapter, so thank you.

Ms. Elvira Honie: Thank you everybody for having us on again. Today, I'm going to be given reports for our Pfizer

Elvira Honie – John Hopkins

COVID 19 vaccine trial. Not much has changed since our last report from last month's meeting. I just wanted just to give updates that are, I think most of you are pretty familiar with our reports that we're giving every month. We want to make sure that we're keeping the community up to date as far as where the trial stands. So, for this trial, we have given everybody that did participate in this trial the first and second dose of the COVID 19 vaccine. As far as the booster doses, we also were able to enroll all of those participants at the end of July, early August. We are in the next stage stages of this vaccine study, where we will be unblinding our participants that randomized study. So, half of those participants did receive placebo, half did receive booster doses. So, I'm sure many of you are quite aware that booster doses are now being available to starting to be available to a certain group of people. Some of those people that did meet the criteria not too long ago, just at the end of August, early September were those that were immunocompromised, meaning those that did have underlying health conditions that were severely at risk. So, I do know that a lot of people in the community thankfully were able to those doses and soon will be. The excess is going to start rolling out booster doses for those that did receive their first and second Pfizer COVID 19 vaccine. So, you should be hearing updates as we are what's just kind of a day by day thing right now, as far as what we're that we're getting from us as far as how they're rolling out booster doses to the community. But for our study, we will be informing the rest of our participants as well. We'll be doing the unblinding process, meaning we'll be letting them know whether they've received the booster or placebo and if they did indeed receive placebo, we'll give them at that time the opportunity to receive the booster dose with us. And again, we'll be following them for a year and the things that we'll be doing over the course of that year. Of course, Will will be screening them with our study provider as well as collecting blood to measure those antibody levels. With the interim analysis of those tests that were done, it did show that the booster dose did show good results. They did show that there was a very significantly higher antibody response against the SARS-CoV-2 virus that causes COVID 19, and it did show a good responses against the beta and also the Delta variants that many of you have heard about in the news lately. And this is just compared to the levels of people that did receive their first and second dose of the COVID 19 vaccine. We'll also give the opportunity to our other participants who initially weren't eligible to receive the booster dose back at the end of July and early August. So, we'll also give them the opportunity, maybe because they were unavailable or didn't meet the criteria at the time. But now that they do, we'll also be offering them those doses as well. There is a meeting for Navajo Nation IRB to meet with our Johns Hopkins IRB as well tomorrow, so we should have much more news at the next meeting. So that's my report for today. Please let me know if you guys have any questions.

President Rosanna Jumbo-Fitch: Awesome, thank you, Elvira, for your report and your updates, I know you provided an update at our Planning meeting as well with your team and all the studies you guys are completing. And I think you guys are doing a great job and doing good and keeping our community informed as well. So, we'll open up the floor for any questions or comments from those that are on the call that you might have for Ms. Elvira and her team.
