- d. Me. Keona Manuelito: Introduced herself with clans and where she is from. I am a student who is completing a Master of Public Health Program at New Mexico State University. I've come to request the Chinle Chapter's approval for a study I'm planning for my master's thesis. I am requesting approval for both Chinle and Canyon De Chelly Elementary. I am proposing a study that exact factors that may contribute to obesity in Navajo children. The title of my proposed study is Psychosocial, Environmental and Psych and Psychosocial Influences on Diet Intentions of the Navajo Children. A secondary data analysis of the Yeego Healthy Eating and Gardening Project Children's Baseline Survey. For this study, I plan to use data that was previously collected through the Yeego Healthy Eating and gardening project Whose leads were Dr. .... from the .... Cancer Research Center in Seattle, Washington. Dr. Kevin Lombard of the .... of Agricultural Science Center, located in Farmington. Their project was a first for the .... Partnership. The research protocol for the original Yeegoo Project was submitted, reviewed and approved by the Navajo Nation Human Research Review Board. This ... Reviewed all the research studies conducted with the Dine to ensure its safe and respectful of our population. In my proposed study, I will conduct a statistical analysis to examine how Navajo children, beliefs and environment are related to their intention to eat healthy food such as fruits and vegetables. For my proposed study, I will use the children's ..... Lombard's Yeego Project. I plan to present my findings and any plans for conference presented publication for Navajo Nation research ....or the approval The Navajo children. Dr. ..... And Dr. Lombard recommended I obtain resolution support for my proposed study from the chapters in the catchment area of the Yeego Project. They also suggest I submit my study for review and approval by the Navajo Nation Human Research Review Board. No additional participants will be recruited for this proposed thesis study. I am working with Dr. Rebecca Palacios, Associate Professor in the Public Health Sciences at New Mexico State University. She is my my thesis and mentor. Lastly, I just wanted to just say thank you so much and to show my appreciation to the chapter for considering my approval for my proposed study and for allowing me to speak today. of Economic Development in regards to what other documentations or other items that need to be completed in order to have this project move forward. So, we're trying to keep everybody informed, not only of the government within the Navajo Nation. So, we're able to work together with the various departments. We still have a couple of letters that we need to update. So, we're working on that internally to get updated support letters as this project has been going on for years. Overall, we're continuing to push that forward and hopefully get the project out for solicitation. So, that's the goal. We do continue to move on that one. So, other items we've been working on, we've had a work session on June 25th, myself and Chinle Chapter Administration were in attendance. We went over our entire project list ever since we were elected into office. We went through one by one. We were able to review and get comments and updates on projects. So overall, we provided an updated checklist. We were able to provide other items and document what else needs to be addressed. And we were able to get information with other tips from other departments and what we need moving forward. So we also wanted to propose a couple of new items which we're going to move on updating throughout the year. We've also been working closely with the Navajo Nation EPA to review the solid waste ordinance and provide a framework. This is becoming a huge issue within the Navajo Nation, specifically the Chinle community. So we highlighted a couple of those items during our work session as well. We want to work with the Navajo Nation EPA, I'm sorry, and provide updates. I requested for their department to also present at our next regular chapter meeting in order to provide information not only to our community, but others throughout. We wanted them to provide updates in regards to the solid waste code and ordinance that is currently existing. And also note any amendments that have been made and also go through step by step of what the process is in order to try to adopt this or that. It is an item that I think would be beneficial not only for the community, but for the entire nation to provide this framework. Chinle Chapter would be the first to kind of provide some stepping stones to help clean up our dump sites, as well as help inform our community members of the trash issues we have throughout our areas. So we are going to request for them to attend our meeting. They have confirmed to review and kind of give our community members some information as well so that we are preparing for that solid waste ordinance as well as other items we're working on. We've had meetings with our community wellness teams. We've met with a couple of individuals from the IHS Department, the Diabetes Program, and we've met with a couple of other supervisors as well. We've sent out meetings, requests. They wanted to provide some information to the chapter, but also to provide information to our Delegate in order to provide community wellness options for our community members. Right now, they're currently serving close to a thousand. They were serving close to a thousand community members prior to it. And it ranges from 13 year old up to seventy-five years and older. So, they see the issues of obesity. They see the issues of health concerns. And they also want to bring forward the overall goal of keeping our community members healthy and also possibly doing work sessions. So, we kind of did a overall discussion with the various departments and they're wanting to really push something forward. So, we're able to provide a support resolution. Currently, the Community Wellness Department provided a ARPA proposal for the Window Rock area. So they're trying to branch out that for Chinle as well, since they do serve the hospital community, they serve the youth, they also serve just the overall community members that are interested in working on their health. So, that was some information we last reviewed. But moving forward, they want to provide more information. They have gathered some data and they are releasing it so that we can kind of move forward. And overall, the goal is to try to push something into a planning phase. We obviously know it takes time to move items forward, but overall, they're making recommendations that they would like the chapter support. Other items we're working on is also the

Sihasin Funds. We've been meeting with our CPND Department in regards to updated templates, MOU, MOAs. In order to get funding for our projects. Our FY 2021 has a variety of projects such as the N7 Solar Street Light. So, we have submitted those documents to the Window Rock office. So, we're now awaiting the next steps. We're also planning to use some funds for our South Manuelito Well. So, we're really prioritizing those areas so we're able to provide better services and also safety items for our community members. Other items we are also pushing is overall. Just to follow up on the ARPA, I know we talked about it at our last meeting. We did submit eight proposals. So that is some items that we are waiting for feedback on. I've also had previous discussions with the veteran's community members at our last meeting at the Dr Guy Gorman nursing home. We also provided invitation to invite them to our next chapter meeting so they're able to provide updates for the veteran community. I know a lot of departments are finally opening doors, so we're wanting to provide them the opportunity to inform the community members. So, at the next meeting, we're going to invite those three departments to present at least the 5-to-10-minute report so we can get information out. We're also working to contact other departments to get updates as we move forward with ordinances and also supporting different projects throughout the community. We also have a couple of other departments that we have to readdress once we answer questions. So, we'll probably be doing our follow ups with our Business Regulatory Office as well as our Economic Development Office. And we're also trying to work with our Enforcement Departments because we're pushing to review enforcing the ordinances if we do move forward with it, so that we are compiling data and information on how we can move forward with certain projects And overall just information As well. Other than that, that's what we've been working on the past two weeks. So, moving forward, again, we're trying to provide information for our community members and we get requests every day. Williams being the D.J. So I did get favorable comments as well. So, just wanted to request for some of that documentation to be forwarded to the elected officials. CMA- 16- 20, which previously closed Navajo Nation roads to visitors and tourists. So, I think this is going to be very important for our community because we do have businesses that gain from tourism within our community and that needs to also be addressed where we invite them to the to the table and talk about how they're going to ensure the safety and then also for our local businesses. And then we also have the CO-84-20 dash, which previously opposed the in-person school instruction due to Covid-19. So, we did recently pass a resolution to allow for Chinle Unified School District, as well as other schools within the vicinity to allow families that are not in opposition to in-person school instruction. So that's another one that's coming up. And then also CJY-66-21. Which allows meetings through telecommunication for chapter subcommittees, community land use planning committees, agency regional and district councils chapters and agency veteran organizations. So, with that, I believe that we can go ahead and try to make accommodations for our community members to move forward to meeting the twenty-five (25) member quorum to allow them back to start with the in-person meeting. So I am in support of that and I've heard a lot of support from community and voters on that. And then also CMA-09-20. Which temporarily reduce chapter meeting quorum requirements. So, as far as this resolution, the chapters have 90 days to return to the minimum of a twenty-five (25) person meeting. But since we have been having large events in the community, I feel like we are prepared and we've been doing that so far. So that would be my recommendation to allow for in person a regular chapter meeting, if not this month, then for next month. So those are the only things I have as far as our reports. The only question that I had was the veteran community, the three departments that we're going to be inviting. I also want to request to add State Representative Jasmyn Blackwater Nygren just to do an introduction of herself to the community. I believe that there are several projects from the nursing home, the guy Gorman nursing home, as well as several projects regarding roads that are going to be requiring some support. So just for us to introduce ourselves and also for her to introduce herself, the formality is so that's just what I'm requesting. If we're going to be inviting different departments, that would be my requests. I been making that request since January. So, what I'm asking for assistance to get her to be invited during our next chapter meeting. I just want to say thank you to those that are on the line, chapter officials and then our LDA Dedman and then our Chapter Administration. That will be all.
