a. Matt Brogdon - Fann Contracting

He gave a report and it is attached. He requests space for trailers for the workers. They will be hiring community members. They are going to re-do 83 driveways and culverts due to very little shoulder space. They are willing to work partnership. Chapter President Dr. Rosanna Jumbo-Fitch: Questioned about the water they are going to use.

Mr. Matt Brogden: They will get water from Alta Warner and Apache county because the well is down and will pay per gallon when then well is repaired.

b. Glenda Davis - REZO

Ms. Glenda Davis: Glenda talked about her initiative about animal wellness on the Navajo Tribe, horse, and pets. They are requesting an amount of \$267,184.00 to address the serious dog issue on the Navajo Nation. There are 54, 000 roaming animals which cause a nuance, dead on road, destroying property. Animal rescue was approached in January for a proposal to be submitted. They are going to partner with animal control. There will be (20) vaccination sites, Free deworm, microchip, (4) Mass surgery with 1,000 per site in (4) days. It is a very aggressive. For health and Safety and Animal control ordinance. Clean up our community. 4 pets per household. Many comments, and emailed all 110 chapters. One comment was read: "Merissa Jones from Fort Defiance comment on #0052-22 legislation. To many dogs roaming that do not belong to anyone. Her 13 y/o Daughter was mauled and not much was done". Ms. Jones commented on her daughter being mauled by dogs. This is something that should have happened a long time ago, stated Ms. Davis. Children Mauled and disfigured. It is not normal to see dead dogs along the roads. This initiative might be funded and would like to be funded by June 2022. Chinle Chapter selected for mass surgery site and will tie up for 5 days. People are going to elder homes and have animals brought to Chapter on Monday. They will do (250) two -hundred fifty surgeries a day. They have a team of 5 surgeon and a team of 15. We really need to make it happen. She thanked everyone for our time.

Chapter President Dr. Rosanna Jumbo-Fitch: Questioned if it will be a pick up for stray dogs?

Ms. Glenda Davis: People need to bring in their animals. There will be five sites. Referrals for surgery are for Navajo Nation residents, which requires a Driver Licenses (DL), or Utility Bill is the only way to get surgery.

The Talbot house was used to counsel those that drank. And it helped them. He was asked by Freddie Brown to help. He owns a building at the Apache County that can be used in place of the Talbot House. It has been three years. He has been meeting with NN President, Delegate Eugene Tso. People are now meeting on Fort Defiance which is far for some. They want to obtain a building with the funding that was received. They can use for repairs and renovations. They can then use the building for rehabilitation. That is the reason they have come today. He requested \$463,868 for the use of providing for Covid-19 testing, temperature taking and vaccination for those attending meetings. There will be people coming and teaching rehabilitation, post treatment, then those that need to come back for more treatment. He want to partner with others. Treatment id about \$1,400.00/ day. It is different when people come home and have to come back again. However if we have a building that why they come in for treatment. He spoke about his personal sobriety achievement. Treatment is the only way. They are working with people that have gotten degrees in Substance Abuse. He states Fort Defiance is 24/7. Mr. Foster spoke about the past in recovery of substance abuse and how it has changed.

Mr. Jim Littlesinger: he is thankful they gave a report to help the elders. He shared about his view on helping those that he see that need help. He shared about his past about how he had started his substance abuse. Mr. Jim talked about the places he has been to get his speeches out and they also collect donations. He wants to do this building first. He introduced himself.
