be made out of them. That is what he has been working on. He states that we pass the word. There was also mention of giving back brands and he will be using Tallies to give citations for over grazing. He talked about having over the limit livestock that could be taken and auctioned. They have been working on those. Chinle has 36 windmill units that have been repaired, water overflow, trough stolen and looks for culprits. He talked about his experience with a gun brazen before him. He did recover one trough. He talked about people climbing to top and moving the steel tubes to pump water. He covered the AIF contributions that were given to the community. He described the reactions of a salt block and the affect in the off springs. Oscar worked on home site lease and some have been approved. He is to be selective and sign for those that reside on the Nation. They will be taking applications and verifying the person signing the consent form. Some have been forged. On April 26<sup>th</sup>, will be meeting with Water Development about N8095, 3 acres will be withdrawn for Friday, and Saturday 10/hr a day to keep the heavy equipment in. They will be hauling materials from Kayenta. They are also discussing the dogs. He wants people to contain their dogs. He says it works to take care of them. He states he travels the boundaries. They might put up a service line fence and he gave all the locations and areas.
