Discussions:

S/T RoAnn Burbank: request the wording applicable laws needs to be clarified to Navajo Nation Laws, and the policy is the Chinle Chapter Policies.

ARPA Representative Sharon Yazzie: states not to add or change or go against her opinion about S/T request because it is adding more bureaucratic and red tape to the resolution and that the contract was already reviewed and approved by DOJ.

S/T RoAnn Burbank: Chapter is not allowed to make up laws and rules going along un-employing workers and the contract is not the same as the resolution. There is no contract attached.

Community members: asked about what TANF was for and also spoke about the lack of employment for adults, and achieving retirement.
