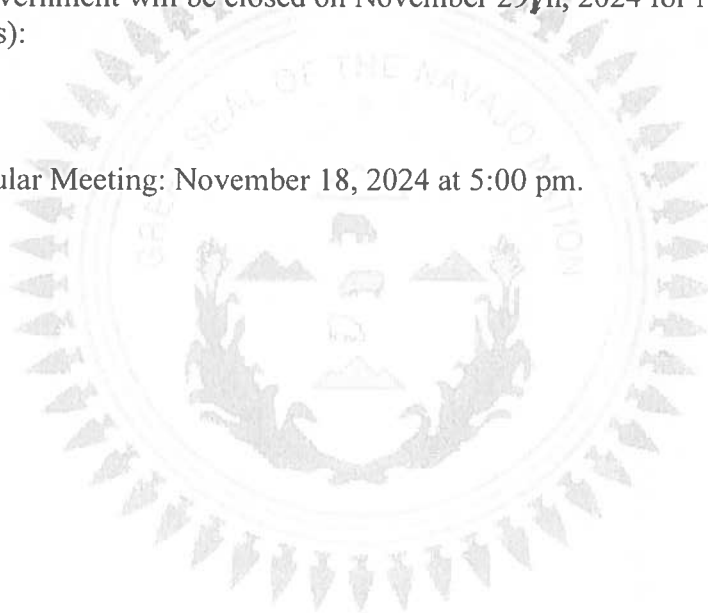








Grazing Representative Oscar Bia Sr.: stated that there were no Home Site Leases (HSL) in the area however there was a gas, Water, Electric Right-of-Way and only one Grazing Permittee in the area the Navajo Veterans Organization (NVO) wanted to start a Business Site for the Veterans.

Sharon Yazzie: States there are multiple Right-Of-Ways that will all take up area and there might not be anything left for NVO to work with. Sharon also informed Valerie that she would have to start with RBDO because they will issue Business Site Lease and it is too early to ask for a Support Resolution. There was still research that needs to be completed.

Valerie Allen: requested to put the resolution on hold until she was able to do more research on the Business Site Lease request.
